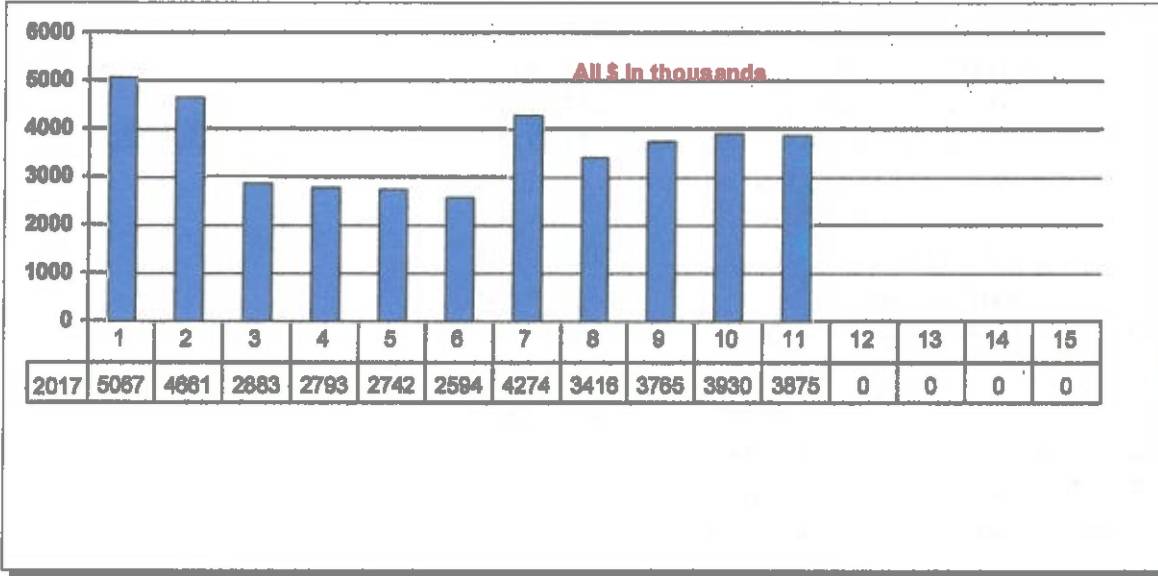
# Section 1 – Cash & Investment
